3. WRC Community Transport Fund Distribution

- Community Transport fund application open 19th November and closing on 10th of December.
- CT Grant fund budget available per annum is \$200,000 to support CT groups.
- Good to let us know how much is needed (even if in excess of \$20,000) when applying although we cannot guarantee the full amount requested would be approved.
- Reassuring applicants that receiving a grant from Waikato DHB/Te Whatu Ora would not be "double dipping" and would not preclude them from applying to Waikato Community Transport Fund for whatever else they may require, as this is a separate pool of funding.

4. Accountability Report

- We are still in the process of finalising the Accountability Report and the recipients of the previous funding round last July will be contacted directly once finalised.
- The accountability report from the previous round of funding won't affect whether they will be approved in the current funding round (FY 2024).

Some of the questions that will be asked in the Accountability Report:

- How many trips undertaken
- What kind of trips
- Share some stories / who was impacted

- Volunteer hours
- Updated copy of budget

Proposed pattern schedule of Fund distribution from this point on:

- November December: Funding application round
- January February: Approval of applications
- By March: Distribution of funds
- September: Accountability report (interim) due
- March: Accountability report (final) due

5. Fuel card

Some benefits of fuel cards:

- Considerable discounts on fuel
- Track Purchases
- Detailed Reports

- Enhanced security and fraud prevention
- Food and Drink Discounts
- Reward Programs*

- Promo periods
- Discounts

6. Te Whatu Ora Commissioning Operating Model

Rachel Haswell provided a fairly high-level presentation to understand what the new operating model, outlining the structure. See presentation.

Norma Taute, our liaison with Te Whatu Ora, has taken on a new locality role. That is still evolving but she will come back to us at the March 2024 meeting hopefully with an update on the next Community Health Forums and whether it will be her, or someone else, who is our future health contact.

7. New Venue and timing

Rototuna Library will be the new venue for the next forum meetings. We received feedback to trial having the time range from 12:30 to 2:30pm.

8. Anything else:

- A request to have a support person or nurse aid trainer on the Taumaranui bus/shuttle.
- A request to have ethnicity in the labels of NTA form as its needed for their reporting to Te Whatu Ora and some patients are reluctant to give this information on request.
- Suggested to have someone representing ACC and also WIC attend the forum.
- Will invite Volunteering Waikato back to present again to the forum on tips for attracting new volunteers.
- A 3-month trial bus connector service between Coromandel Town and Thames with a possible extension to 6 months has been approved. The service will go from Coromandel town to Thames and back 4 times a week starting on Monday 18th December and connect with the Intercity bus timetable. Info flyer found here.
