## 2. Elderly Travel Behaviour – Chan Kim, Lecturer in Transport Engineering, Wintec

Chan presented on 'Improve transport accessibility for the rural community: A Study on the Introduction of Demand-Response Transport (DRT) System to New Zealand'

- The trend of Elderly Population in NZ,
- Travel Behavior and Modal Share of Elderly in rural
- A case study in the Thames, Coromandel.

Based on the preliminary study, comprehensive research requires a great deal of collaboration among practitioners (e.g., local community transport providers, DHB, Councils and NZTA) to investigate,

- Factors Influencing to Elderly's Travel Behaviour on Transport Mode Choice in Rural (e.g., local trip vs Intercity trip)
- Develop a better operation system: Centralised vs Localised vs Hybrid-model (Ridership vs Operating Cost)
- System Architecture: Service and Operation (e.g., Fare, Booking, Route/Routing, Drivers, etc.)
- Benchmarking overseas cases (e.g., \$1 Taxi, Uber)? or other options?
